Extraordinaire Magazine 25-Pack Auto-Ship Purchaser Terms and Conditions

The Purchaser hereby agrees and understands that they are purchasing Lightyear's *Extraordinaire Magazine* 25-Pack (the "Magazine") on an Auto-Ship basis ("Auto-Ship") as a promotional tool to encourage individuals to become a MyWirelessRep.com Representative.

The Purchaser has agreed to purchase either the *Extraordinaire Magazine* Challenge Plan (the "Challenge") or one of the Standard Monthly Bundle Plans (the "Bundle Plan"), on an Auto-Ship basis, and the following terms apply to both plans:

1. A minimum monthly purchase of one bundle of 25 Magazines may be purchased per month. The Purchaser is limited to purchasing four (4) bundles in a month;
2. Purchaser will be charged for the Monthly Recurring Charge ("MRC") associated with the Auto-Shipment of any Bundle Plan, and any applicable taxes or shipping charges.
3. The Purchaser must provide Lightyear with a valid credit card in their own name when the 25-Pack is ordered. The credit card used to order the first Bundle Plan will be charged automatically each month for the same number of Bundle Plans as was originally ordered. The full price for any Bundle Plan will include all applicable taxes and shipping costs. The Purchaser's credit card will continue to be charged automatically, until such time as the Purchaser cancels the Order by calling MyWirelessRep.com Rep Support. If the credit card expires, Purchaser closed the credit card account, Purchaser's billing address changes or the credit card is cancelled and replaced because of loss or theft, Purchaser must advise Lightyear immediately. Lightyear may terminate the auto-shipment of the Magazine at any time in its sole discretion, if any charge to Purchaser's credit card on file with Lightyear is declined or reversed for any reason.
4. Magazines will be shipped usually within 24 to 48 hours of each billing.
5. Lightyear shall not be responsible for delays and failures in performing its obligations due to circumstances beyond its reasonable control, such as acts of God, strikes, labor difficulties, riots, war, fire, death, curtailment or interruption of a source supply, government decrees or orders, or when performance becomes professionally impracticable, etc.
6. Purchaser is responsible for, and shall pay any applicable federal, state, municipal, local or other governmental sales, use, excise, value-added, personal property, public entity or other taxes, fees or charges now in force or enacted in the future, that arise from or as a result of the purchase of any Bundle Plan of the Magazine.
7. The Purchaser is responsible for inventory management and security of the Magazines. Lightyear will not reimburse the Purchaser for any Magazine lost, stolen or damaged after the Purchaser has received their shipment.
